And, finally, dear church, you have shared the gift of the realness of God's love with the world around you. MINUTES OF THE 2022 ANNUAL CONGRESSIONAL MEETING

LUTHERAN CHURCH OF THE HOLY SPIRIT

SUNDAY, JANUARY 22, 2023

Call to Order: President Jan Schwanke called the meeting to order, at 10:37 a.m.

A quorum was present.

Opening Devotions: Pastor Tim led devotions.

Adoption of Agenda: Jan Schwanke presented the agenda. Janice Edwards moved that the agenda be adopted. The motion was seconded by Ken Rosko and carried by voice vote.

Acceptance of Minutes: President Jan Schwanke asked for a review of the January 16, 2022 Annual Meeting Minutes. The Church Council moved for approval. Ron Stocks seconded the motion that the minutes be approved as printed. The motion carried by voice vote.

Report of Nominating Committee: Jeanne Nelson spoke on behalf of the Nominating Committee and noted that a position for the 2023 Church Council remains open (Fellowship). Jeanne Nelson presented the following individuals as nominees for Church Council: Kari Davenport, Andy Eastmond, Nancy Fencl, Wayne Giampietro, and Allison Wyrwicz. No additional nominees were presented. Joe Labellarte moved to approve the slate of nominees; Jeanne Nelson seconded, and the motion carried on a voice vote and by a show of hands.

Pastor's Report: Members were directed to the Annual Report. Pastor Tim reflected on the activity of the last year and noted the challenges presented by the pandemic but also the vibrant activity of the congregation despite these challenges, including the addition of new members. Pastor Tim also noted financial challenges posed by the pandemic and loss of members through relocation and passing to eternal life. We are looking forward to a continued return to normalcy in 2023. Donna Williams moved to accept the Pastor's Report. Al Edwards seconded and the motion carried on a voice vote.

Membership Notes: Jan Schwanke referred members to the 2022 membership statistics.

President's Report: Jan Schwanke referred members to the Annual Report. Donna Williams made a motion to accept the President's report. Joe Labellarte seconded and the motion carried on a voice vote.

General Fund Operating Statement: Daaron Dohler referred members to the General Fund Operating Statement, noting the generosity of members in December in response to the year-end operating deficit.

Treasurer's Report: Daaron Dohler referred members to the Treasurer's Report and statements in the Annual Report. Daaron highlighted entries regarding assets and liabilities, and the treatment of designated funds within the overall budget. Daaron noted that stewardship pledges for this year increased over last year, and it is hoped that ongoing increases in weekly attendance will result in increased revenues in 2023. There was a

- discussion of proactive efforts ongoing and for consideration to limit operating expenses and increase revenues. Donna Williams moved to accept the Treasurer's report. Joe Labellarte seconded, and the motion passed by a voice vote.
- **Building Fund Report:** Daaron Dohler presented the Building Fund report and discussed pledges from the campaign and amounts received, with receipts trending well. Daaron noted that a new building fund appeal will be undertaken this year. Arne Bilstad made a motion to accept the Building Fund report. Carol Duprey seconded, and the motion carried on a voice vote.
- **Council Committee Reports:** Committee reports were noted with the congregation being given the opportunity to ask questions or comments. Janice Edwards moved to accept the Council Committee Reports. Larry Brady seconded, and the motion carried on voice vote.
- **Endowment Report:** Ken Rosko referred members to the Annual Report and discussed the function and outreach work of the Fund; he also noted the Fund's performance relative to the performance of leading market indicators. Joe Labellarte noted a typographical error in the disbursement entry in the report as to the calendar year. Donna Williams motioned to accept the Endowment committee report as amended to report disbursements in 2022. Joe Labellarte seconded, and the motion carried on a voice vote.
- **Columbarium Report:** Nila Bilstad referred to the Annual Report, noting two interments and four niche purchases in the past year, with 35 niches remaining. Ken Rosko moved to accept the Columbarium report. Jeanne Nelson seconded, and the motion carried on a voice vote.
- **Benevolence:** Jan Schwanke referred members to the Annual Report and noted a reduction to benevolence paid to the Synod. Joe Labellarte moved to accept the Benevolence Reports. Nila Bilstad seconded, and the motion carried on voice vote.
- **ExPOS Report:** Jan Schwanke referred members to the Annual Report. Al Edwards moved to accept the ExPOS report. Janice Edwards seconded, and the motion carried on a voice vote.
- **Finance Review Committee Report:** Allison Wyrwicz referred members to the Annual Report and acknowledged committee members. Kelly Wittich moved to accept the Finance Review Committee report. Al Edwards seconded the motion, and it was approved by voice vote.
- **2023 Budget:** Daaron Dohler presented the proposed budget, which was reviewed. Daaron discussed the chart included in the Annual Report and noted that three categories of expenses predominate that largely are fixed and essential. Joe Labellarte moved to accept the 2023 budget. Al Edwards seconded the motion, and it was approved by voice vote.
- **Declaration of Election Results:** The election was approved by voice vote at the beginning of the meeting. Kari Davenport, Andy Eastmond, Nancy Fencl, Wayne Giampietro, and Allison Wyrwicz were elected.
- **Recognition of Council Members:** Jan Schwanke and Pastor Tim expressed appreciation for the time put forth by Council. They and the congregation gave special thanks to the retiring council members: Larry Brady, Ruth Ann Grockis, and Donna Williams.

Adjournment: Donna Williams made a motion to adjourn. Ken Rosko seconded the motion, and it was approved by a voice vote. The Congregational Meeting was adjourned at 11:30 am.

Our greatest joy is our children Elizabeth (who lives in Hawaii with her husband and our grandson), Stephen (Evanston) and Christine (Salt Lake City). Michael, who retired in 2021 after an enjoyable career as a chemical engineer, is a lifelong Lutheran.

Kelly Wittich is honored to continue to serve Christian Education on the LCHS council for a second term. Kelly and her two children have been members of LCHS since 2013 when her daughter was born. She also teaches Sunday school and pitches in where she can for other LCHS human needs efforts and fellowship events. Her two children love attending LYFE on Tuesdays and she just completed her first attempt at the Christmas Orchestra. She is a physical therapist currently overseeing health and wellness benefits for the United Methodist Church.

PASTORS REPORT 2023

As we look forward and anticipate a new year of celebrating God and God's presence with us, we have much to celebrate and be thankful for.

During the past year, it's been great to see our attendance numbers go up in worship, and to have more participation in our children's programs and music programs. And we give thanks to God as we celebrated and welcomed 40 new members, who have joined our congregation. And thanks to a memorial gift in honor of Margaret Bahls, we have a new transformed look to our Gathering Space. God is certainly doing some new things in our midst, and I believe as we enter into a new year, the call for us to embrace a spirit of innovation is quite evident.

We made some innovations in the past year, in our focus on hospitality and welcoming guests to our church, but as we did, we identified some areas to grow in. We learned that although we are "The Church in the Woods", we are not easy to find and our visibility is hidden in the trees we love. New signs and advertisements and welcoming practices are needed so that we are better known in our community for all our contributions and opportunities. Some of us have been talking about a new logo with a new image to foster greater awareness and visibility.

It has been great that we are now live streaming our services on YouTube and we give thanks to those volunteers who are bringing us into many homes. But we also have some pretty significant problems in our broadcasts due to our sound system which is outdated and needs to be replaced. A big challenge for us this year is to not only invest in a new sound system, but also to upgrade our social media presence and acquire the help we need to get us there.

Many thanks must go out to our staff for their dedication and commitment to the work of our church. Ciara Crews completed her first year as Office Manager and we welcomed Karen Jirsa as our new Choir Director. Their gifts, talents, and hard work, to improve our social media presence and develop of our music ministry have made a tremendous impact on our congregation already. We also give thanks for our incredible children's ministry staff of Jennifer Williams and Bill Vaananen who never fail to provide innovative and inspiring programs and events for our kids and families. And we give thanks to our wonderful organist, Kathy Roderer, and Nancy Fencl, Patrick Cantagallo, and all who inspire us with their musical gifts. There are so many more to celebrate and thank, like our church council, the prayer team, our fellowship event volunteers, and I could go on and on. We have a wonderful ministry here at Holy Spirit and I hope we all recognize, appreciate, and celebrate the great things God is doing here through us.

CHRISTIAN EDUCATION CONTINUED

Although we have some financial challenges, we ended the year much better than last year and we continue to systematically pay down our mortgage debt. Who could have anticipated that a lightning strike would hit the church and destroy outdoor lights, copiers, computers, phones, and other equipment. And that we'd be replacing another furnace, refrigerator, and finally repairing the women's bathroom. And yet, we continue to thrive compared to many churches who are also experiencing the challenges of coming out of COVID, and the general cultural shift away from being committed to the work of the church. As our church gets older, we continue to lose some of our long-time faithful givers as well, so we will need to grow and develop strategies to financially support our mission, because we could be doing so much more with added staff and resources. As with all churches, our financial health depends on the stewardship of our members and the faithful participation in our mission. We anticipate some challenges, but with your support our ministry will continue to thrive.

In the year to come we invite everyone to participate in our new mission objectives. The Long Range Planning Team created a Vision Task Force to identify our mission priorities for the coming three years, so that we can measure our progress and get everyone aligned with our goals. We looked at our mission statement, the demographics and needs of our community, and the many ways we worship God, serve others, and make disciples, and came up with three Mission Objectives to help us focus our efforts for the next three years. Our mission is to:

Build a loving inclusive faith community

Grow in faith and spiritual understanding

Serve others with gratitude and compassion

In the year to come we look forward to utilizing these mission objectives to guide us as we Build, Grow, and Serve, and we look forward to everyone participating and aligning with our mission. Your participation is vital as we need everyone's insights and gifts as we look to expand God's presence, and our influence, in our community.

Thank you all for your love for God and our church, and for all you do to make Holy Spirit a loving, welcoming faith community. 2024 will be another wonderfully blessed year, and I look forward to the incredible things God has in store for us.



Refinancing of the current church debt was completed in January 2013. In January 2020, the interest rate was lowered from 4.125% to 4%. The loan continues with Thrivent Financial with a monthly payment of \$7,283 due.



CHRISTIAN EDUCATION

Christian Education at Lutheran Church of the Holy Spirit is an important way to cultivate and strengthen the faith in children and adults. Our talented staff and the volunteers who lead these programs are integral to the programs' success.

Sunday School

We continue to hold a combined Sunday School class during the 9:30 service, with the children departing following the children's sermon and returning for communion. Teams of 2 volunteer teachers rotate with Children's Ministry Director, Jennifer Wiliams, to teach the combined class. Lessons are Bible-based, with the kids reading aloud, watching videos, completing activities, and everyone participating in discussions about our faith and our relationship with God. Curriculum and planning are spearheaded by Jennifer Williams. We restarted Sunday School choir this year! Nancy Fencl joined the beginning of the combined class on many Sundays to lead them in a number of fun songs. Since both the cherub and LYFE-aged students sang together, we chose to call it the Phoenix choir—rising from the ashes after COVID. Everyone had a lot of fun and shared their talents with the congregation a couple of times in 2023.

A number of Childrens' fellowship events were held throughout the year, including our float building and parade for Mardi Gras (new and improved and sans the sharp box cutters), an Easter Egg hunt (with the community), a bounce house, Trunk or Treat and more. One third grader took her First Communion in March 2023.

Confirmation

Seventh and eighth graders participate in Confirmation class on Tuesday evenings. Confirmation fosters growing knowledge and understanding of the Bible and Christian faith, with a specific focus on Lutheran traditions and identity. The program also provides an opportunity for service and getting involved with other ministries in the church. The individualized learning format allows for flexible class schedules with clearly defined expectations and goals for the young people in their growth toward becoming confirmed members of LCHS. The confirmation class led our Youth Sunday on February 12 and had a confirmation retreat the evening of February 10. The confirmation-aged youth also hosted a Car Wash day of service in October. Two confirmands completed their Affirmation of Faith and became full members of our congregation on May 7, 2023.

Tuesday LYFE

Lutheran Youth Fellowship Experience (LYFE) is a vibrant youth program offered on Tuesday evenings to 2nd–6th graders. It brings faith and friendship into the weekly lives of the students who participate. LYFE begins each week with a faith and fellowship activity led by Jennifer Williams, followed by Music with Bill Vaananen. LYFE attendance has been strong and the LYFE choir has sung a record number of times during church services this year. The

annual LYFE Christmas program, *Silent Night*, told the origin story of the popular Christmas carol by following the story of a pastor and music director from Oberndorf, Austria after the church's pipe organ broke one Christmas. We followed the program with a congregational Christmas carol sing-a-long with Mr. V. What a beautiful tradition and way to celebrate Advent!

Summer Activities

Once again, we made the decision not to offer Vacation Bible School (VBS) in 2023. Significant volunteer support is needed to make VBS successful, and survey about interest in attending and volunteering for VBS in 2023 helped us determine our path. Family activities included a "s'mores and more" evening fellowship session in June and a summer Sunday School activity during church with family activity following church where we made bird feeders to hang around the property in July. In August we held our traditional Backpack Blessing with a visit from the Kona Ice truck that everyone got to enjoy!

Thursday Bible Study

The Thursday Bible Study group has continued to meet throughout 2023. Topics included: Philip Yancey's books, The Jesus I Never Knew and What's So Amazing About Grace; Robert J. Miller's The Complete Gospels; and a unit on Five to Thrive as a Christian. Bible Study meets weekly from 10:15-11:30 and all are welcome.

Adult Education Opportunities—Ideas Welcome!

We continue to explore opportunities to resume our adult Christian Education forum, which used to take place between services on Sundays. Timing for this is challenging due to multiple musical ensembles at LCHS holding their practices after services. We continue to explore ways to bring adult Christian Education back to our congregation, in a new way. We encourage congregation members to share their ideas for education topics and timing with the Church Council as we consider our options. We are also excited to share that our Book Club resumed on Fridays this year. All are welcome!

Library

The LCHS Library continues to offer reference materials such as Bible maps and atlases and introductory materials to other religions. Children's books are also available as resources for home-based religious education. Adult religious material (fiction and non-fiction) is available as well. Check out something new—keep it or pass it on. No due dates!

CHURCH GROWTH

Church Growth and Hospitality - 2023 Membership at Holy Spirit stood at 550 baptized members and 470 confirmed members at the end of 2023. In-person worship service remains at 9:30 am. LCHS continues to offer FaceBook Live and a YouTube channel to virtually minister to those who prefer viewing services from their own homes or afar.

GROWTH

Our community presence and support to our neighbors occurred in a variety of ways. Advertising in Lincolnshire's kiosk for 2023's Blood Drive, Trunk or Treat, Thanksgiving Service, Christmas Eve Services and Easter Services hung for one week at a time. Social Media (Facebook and Instagram) as well as D103 Newsletters' publicity created increased community members' participation at many of our offered events.

Although Holy Spirit did not march in this year's Buffalo Grove Pride Parade (in June), our Ainancial support allowed LCHS to be a publicized sponsor and supporter.

For the first time, we also sponsored local school districts through various fundraising efforts. As a sponsor of the D103 5k (in May), LCHS' name was on the back of every participant's t-shirt (estimated 700+ people), and a small hand sanitizer bottle (with our info) was in every participant's 'swag bag'. As a D125/Stevenson HS sponsor, Holy Spirit's information was printed in every sports catalog/game day guide for the '23-24 school year.

On-going support of our visitors included personal, hand-written Cards of Welcome once visitors' information was shared. Visitors can share their information by electing to use the Google Form connected to a QR code or signing in using our new Guest/Visitor Book. Any email addresses shared are also passed along to the church of office for inclusion in our weekly emails. Two 'New Member' Sundays occurred in 2023 as well. These special Sundays allowed new members to be formally welcomed into our congregation. Welcome Gift Bags and a special hospitality hour following service were part of the welcome celebration.

HOSPITALITY

Meet and Greet Sundays continue at Holy Spirit. Gathering after service on the last Sunday of every month remains a welcomed reminder of Fellowship. Thanks to the assistance of Tom and Eileen Weglarz, Joanne Schwarz, Jill Pink, Margy Eastmond and Trudy Bettiker for their willingness and help.

Our 'name tag' Sundays occur on the last Sunday of the month (or designated Sundays otherwise) when church attendees wear a name tag. Response for this initiative remains positive as

HUMAN NEEDS

PROPERTY COMMITTEE

Our church home, just like our personal houses, demands additional care and maintenance as it ages. During the past year, it was necessary to replace one furnace and one air conditioning unit. Several furnaces and air conditioners are needed to provide comfort throughout our buildings; each also requiring routine maintenance. One of the two commercial refrigerators in our kitchen also failed late in the year and must be replaced. A power surge resulting from a lightning strike in the Spring did considerable damage to office equipment and knocked out some of the parking lot lighting. Thanks to Arnie Bilstad and Ron Stocks, who worked with a contractor to replace the parking lot lights.

The women's washroom near the sanctuary required major refurbishing. Deterioration of the drain resulted in significant subsidence and damage to the floor. The effort of Ron and Arnie to arrange for and work with a contractor to execute a repair and floor replacement is much appreciated. This project provided an opportunity to install modern toilets in this washroom as well. Earlier in the year new faucets were installed in the washrooms at the west end of the building.

Other major projects included resurfacing and restriping the parking lot. A big thank you to Jean Gates for repairing walls and painting the narthex and the hallways around the Fellowship Hall. Temporary repairs were made to the flat roof, primarily above the Confirmation and Youth rooms where a major reconstruction will be required in 2024. It is important that our facilities meet the needs not only of our congregation, but also our tenants, primarily the Lincolnshire Community Nursery School, Camp Lincolnshire and True Hope church.

Beyond the functional requirements of the facility, appearance of the property is important both for our congregation and our community. The skills and hard work of all who have participated during our scheduled work days is much appreciated. Thanks also to those who enhance the upkeep of the property on their own initiative. A special thank you to Joel Utterback for his years serving as Property chair.

FINANCE REPORT

The Operating Fund ended the year in a negative position with operating expenses exceeding income by \$7,675, which is less than a 2% variance to the 2023 budget of \$464,402. Benevolence of \$2,500 was paid to the ELCA Metro Chicago Synod. The Building a Foundation Building Fund appeal received pledges of \$312,000 in May 2020, and the Catch the Spirit Building Fund appeal received pledges of \$280,660 in May 2023. As of the end of 2023, total Building Fund receipts are \$123,145. The balance in the Building Fund at the end of 2023 is \$122,210. No mortgage principal prepayment was made in 2023. The current mortgage balance as of the end of 2023 is \$531,246. The mortgage maturity date is May 15, 2031, and the interest rate was reduced in January 2020 to 4.0%. This rate will adjust again in January of 2027. Currently the required monthly mortgage payment of principal and interest is \$7,283. In 2023 we renewed a \$50,000 line of Credit with Bank Financial in case of emergencies. There are no current plans to use this credit, it has a cost of \$250/yr.

Thank you to the members of the Financial Review Committee: Arnie Bilstad, Larry Brady, and Julie Utterback. This committee reviews the church's financial records and provides valued insight into the church's financial state. We give great thanks to Daaron Dohler who as Church Treasurer has once again contributed many hours and much attention to detail this year. Counters Jeanne Nelson, Jackie Murphy, Al Edwards, Phil Brusius, Wayne Giampietro and Tom and Eileen Weglarz take turns counting the monies received the preceding week and preparing the deposit. The information is entered by the Office Manager, Ciara Cruz, into the church's financial record-keeping software.

FINANCIAL REVIEW COMMITTEE 2023

The Financial Compliance Review Committee met with the Church Treasurer (Daaron Dohler) and Council Finance Chair (Allison Wyrwicz) to review the financial records of the Church, along with the procedures of the Church regarding financial matters, the Building Fund, Endowment Fund and Columbarium accounts.

The Committee further finds that the Treasurer maintains the proper records in the proper format. A review of actual checks written during the year indicates the income and expenditures of the Church are properly and appropriately posted to the financial records maintained by the Treasurer, whose records accurately reflect the financial condition of the Lutheran Church of the Holy Spirit.


