MINUTES OF THE 2021 ANNUAL CONGRESSIONAL MEETING

LUTHERAN CHURCH OF THE HOLY SPIRIT

SUNDAY, JANUARY 16, 2022

- Call to Order: President Jeanne Nelson called the meeting to order, via Zoom and telephone due to the pandemic, at 11:01 a.m. A quorum was present.
- 2. Opening Devotions: Pastor Tim led devotions.
- 3. Adoption of Agenda: Jeanne Nelson presented the agenda and noted that item number 13 should be amended to state "2022 Budget." Jan Schwanke moved that the agenda be adopted as amended. The motion was seconded by Tom Weglarz and carried by voice vote and by show of hands.
- 4. Acceptance of Minutes: President Jeanne Nelson asked for a review of the January 17, 2021 Annual Meeting Minutes. Wayne Giampietro moved for approval. Jennifer Prosk seconded the motion that the minutes be approved as printed. The motion carried by voice vote and by show of hands.
- 5. Report of Nominating Committee: President Jeanne Nelson spoke on behalf of the Nominating Committee and expressed deep concern that two positions for the 2022 Church Council remain open (Fellowship and Stewardship). Jeanne stated that the Council will proceed to serve in 2022 with only 10 members but that the Nominating Committee will continue to actively seek to fill the open positions. Donna Williams presented two individuals as nominees for Church Council: Jennifer Prosk and Jan Schwanke. No additional nominees were presented. Barry Nelson moved to approve the slate of nominees; Jackie Murphy seconded and the motion carried on a voice vote and by a show of hands.
- 6. Pastor's Report: Members were directed to the Annual Report. Pastor Tim reflected on the activity of the last year and noted the challenges presented by the pandemic but also the robust activity of the congregation despite these challenges. Pastor Tim emphasized the need for everyone to please give a bit more of their time and talents, as volunteering and service are the life blood of our congregation. Pastor Tim also noted financial challenges posed by the pandemic and loss of members through relocation and passing to eternal life. We are looking forward to a return to more of a sense of normalcy in 2022. We will be emphasizing church growth and long-range planning, and focus groups will be held in furtherance of this mission. Pastor Tim noted the increasing role of technology in the life of the congregation and the need to further develop our technology and outreach efforts. Pastor Tim emphasized the tremendous generosity of our membership, giving to the congregation itself and to community partners. Arnie Bilstad moved to accept the Pastor's Report. Wayne Giampietro seconded and the motion carried on a voice vote and by show of hands.
- 7. President's Report: Jeanne Nelson referred members to the Annual Report. Ruth Ann Grockis made a motion to accept the President's report. Joe Labellarte seconded and the motion carried on a voice vote and by show of hands.
- 8. Treasurer's Report: Daaron Dohler referred members to the Operating Statement and reports in the Annual Report. Daaron highlighted entries regarding prepaid contributions, reduced building use due to the pandemic, and the 2021 forgiven PPP loan. Daaron noted that the approximately \$10,000 operating deficit is almost exactly offset by the prior year's operating surplus, which reflected prepaid 2021 contributions. Nancy Fencl moved to accept the Treasurer's report. Kelly Wittich seconded, and the

motion passed by a voice vote and by show of hands. Daaron Dohler presented the Building Fund report and discussed pledges from the campaign and amounts received, with receipts trending well. Kelly Wittich made a motion to accept the Building Fund report. Jackie Murphy seconded, and the motion carried on a voice vote and by show of hands.

- 9. Council Committee Reports: Committee reports were noted with the congregation being given the opportunity to ask questions or comments. Wayne Giampietro moved to accept the Council Committee Reports. Nancy Fencl seconded, and the motion carried on voice vote and by show of hands.
- 10. Endowment: Jackie Murphy referred members to the Annual Report and noted a distribution for technology enhancements. Pam Labellarte motioned to accept the Endowment committee report. Lisa Ayers seconded, and the motion carried on a voice vote and by show of hands.
- 11. Columbarium Report: Nila Bilstad referred to the Annual Report and noted three interments in the past year and that 38 spaces remain. Jackie Murphy moved to accept the Columbarium report. Kelly Wittich seconded, and the motion carried on a voice vote and by show of hands.
- 12. ExPOS Report: Tom Weglarz referred members to the Annual Report. Eileen Weglarz moved to accept the ExPOS report. Nila Bilstad seconded, and the motion carried on a voice vote and by show of hands. Jeanne Nelson noted that the WELCA and MoST Reports were deleted this year due to the pandemic but noted with thanks the November concert presented by WELCA through Trudy Bettiker's hard work.
- 13. 2022 Budget: Daaron Dohler presented the proposed budget, which was reviewed. Daaron discussed the chart included in the Annual Report and noted that three categories of expenses predominate that largely are fixed and essential. Joe Labellarte moved to accept the 2022 budget. Wayne Giampietro seconded the motion, and it was approved by voice vote and by show of hands.
- 14. Finance Review Committee Report: Larry Brady referred members to the Annual Report and acknowledged committee members. Kelly Wittich moved to accept the Finance Review Committee report. Mary Lou Gilliam seconded the motion, and it was approved by voice vote and by show of hands.
- 15. Declaration of Election Results: The election was approved by voice vote and by show of hands at the beginning of the meeting. Jan Schwanke and Jennifer Prosk were elected, to three-year terms.
- 16. Recognition of Council Members: Jeanne Nelson and Pastor Tim expressed appreciation for the time put forth by Council. They and the congregation gave special thanks to the retiring council members: Bill Collins and Joe Labellarte.
- 17. Adjournment: Wayne Giampietro made a motion to adjourn. Tom Weglarz seconded the motion, and it was approved by a voice vote and by show of hands. The Congregational Meeting was adjourned at 11:44 am.

MEMBER BIOS

The followings individuals have indicated willingness to accept nomination to the Holy Spirit Church Council for the one or three year terms beginning in February 2023. Vacancies on the council are filled by appointment until the next election when nominations are open for all positions. Additional nominations from the floor are accepted but should be made with the approval of the person being nominated.

Kari Davenport has been a member of LCHS for 11 years. During that time, she has served as VBS director, Christian Education Council Representative, Bake Sale Leader and organized the Angel Tree gifts for many years. Kari and her husband, Todd, live in Lincolnshire with their two sons, Luke (13) and Will (11). Kari is a teacher and currently works as a preschool teacher at Lincolnshire Community Nursery School. She enjoys golf, creating with her Cricut, traveling, and hanging out with friends and family.

Andrew Eastmond joined the airport consulting firm Ricondo in 2007 and has led a consulting team responsible for comprehensive air service development at Chicago's O'Hare and Midway Airports since 2010. These efforts have resulted in numerous new international and domestic air services for the City's airports, with O'Hare being ranked the world's most connected airport in 2022 for the first time since 2016. Chicago is also now currently of only four other cities globally to offer nonstop passenger service to the six major inhabited regions of the world. Prior to joining Ricondo, Andrew was the first Fed Ex/United Airlines Resident Research Fellow at the DePaul University College of Law's International Aviation Law Institute and held positions in United Airlines' network strategy and international and regulatory affairs departments. Andrew has a B.S. in Economics from Purdue University and a J.D. from DePaul University College of Law. He resides in Riverwoods with his wife Margy and son Andrew where he is currently a Village Trustee. He is seeking his second term on the Church Board with responsibility for personnel.

Nancy Fencl joined Holy Spirit in 1981 with her husband, David. They raised their now adult children, Amanda, Luke and Rory at the church. The Fencl's live in Riverwoods. Nancy is a retired Band Director and Music teacher from District 103. She fills her time with flute playing, pickleball, gardening and fostering adorable kittens for Orphans of the Storm. Nancy has been an active church member as a flutist, choir/bells / brass member, gardener and live-streamer. This is her 4th term on the church council over the years.

PASTOR'S REPORT 2022

The past year has been a year of renewal and new life, as we've been finding our way out from living under the challenges of the pandemic, to blazing a new way of being the church in today's ever-changing world. It has been encouraging this past fall to see worship attendance numbers increasing and program participation growing, and there's a feeling that we're coming back, but in a different and vibrant way.

Paul wrote in his second letter to the Corinthians about renewal he wrote, "If anyone is in Christ, he is a new creation. The old has passed away, behold, the new has come."

And Ezekiel prophesied about renewal in the classic story of the valley of the dry bones, the Lord said, "Son of man, can these bones live?" And the bones came together, then sinews and flesh covered the bones, and then the breath of God brought the bones to life. And the Lord said, "I will put My Spirit within you, and you will come to life, and I will place you on your own land. Then you will know that I, the Lord, have spoken and done it."

In the life of our congregation, I see both senses of renewal occurring, for we are coming back to life in a new way, and at the same time leaving the past behind for something completely new and different. It's an exciting time to be the church as we hold onto our dearly loved traditions while creating some entirely new opportunities as well.

During the past year we've celebrated God's presence here at Holy Spirit in so many wonderful ways; from our many celebrative worship services and baptisms, to Youth Sunday and Trunk or Treat. We celebrated with jazz and Mardi Gras and with the Hanging of the Greens and the Children's Christmas program, "Light Up, Bethlehem". We celebrated life at memorial services and at the renewal of wedding vows, and we confirmed another class to be the future leaders of our church. We gave towards World Hunger, Holy Family, Lutheran Social Service, COOL food bank, PADS, Angel Tree, and Segrado Corazon. Fellowship returned with pickleball, trivia night, and Octoberfest, and we celebrated Spirit Day, Reformation Day, and Thanksgiving. And above all we celebrated the resurrection of our Lord, for each day we receive New Life through our risen Savior Jesus. It's been a wonderfully blessed and Spirit-filled year in our congregation.

It's also been exciting to see the implementation of our live streaming equipment and our move to utilizing our YouTube channel. As we continue to improve our use of technology, we will not only broadcast worship, but also better connect through social media, reach out to new and prospective members, and provide various means to give financially. These advancements are necessary to keep up with the ways we live today, and we'll need your volunteer help so we can provide these services to others.

The past year has also been a year of reckoning, as we've fallen behind financially after receiving PPP loans that did not need to be paid back in each of the previous two years. For the past 3-4 years, we've lost some significant financial givers, as some have relocated in retirement and others have passed on to eternal life. Those losses to our budget were not experienced when they might have been, but now we're faced with the challenge of overcoming those losses. In addition, although we continue to make great gains in paying down our building debt, our 3-year capital campaign also concludes this spring, and we'll need to prepare for another campaign as we get close to finally paying off this debt. As with all churches, our financial health depends on the stewardship of our members and the faithful participation in our economics. We anticipate some challenges, but with your support our ministry will continue to thrive.

Many are to thank for our success in ministry this past year, particularly our staff members; Jennifer Williams, Bill Vaananen, Kathy Roderer, and Mike Duffy. Laurie Papini, our office manager for the past five years, resigned her position for other pursuits, so we also welcome Ciara Crews to this position and look forward to utilizing her skills especially as we advance our use of social media.

We are also indebted to the volunteer efforts by so many, particularly Daaron Dohler, our Treasurer and Technology mastermind, Nancy Fencl, our Worship and Music chair, Eileen Weglarz, our prayer ministry leader, Jeanne Nelson, who has provided leadership in many of our ministries, and Jan Schwanke, our congregation's president. The leadership and devotion of these faithful servants have contributed enormously to a challenging year in the mission of our church. There are always many more that we could recognize, and we give thanks for you all.

In the year to come we anticipate more involvement in our community and more activities in the life of our church, especially as it becomes easier to congregate socially. We look forward to a year of growth as we enhance our outreach and hospitality, and we anticipate developing more fellowship opportunities. To accomplish our mission and grow our impact on the community, we'll need more support in terms of volunteers, financial giving, and leadership. Our gifts have been given to us for the glory of God and we encourage everyone to explore how they intend to share their time, talents, and treasures in 2023 and commit to making Holy Spirit a church of purpose, a beacon of light in the darkness, and a community that cares and connects with all.

Thank you for the opportunity to continue to serve God's church in Lincolnshire. And thank you for all you do and your ongoing commitment and service to the Lord. We've had an incredible year in ministry together. Let's make 2023 a year to remember!



Refinancing of the current church debt was completed in January 2013. In January 2020, the interest rate was lowered from 4.125% to 4%. In June 2020, a principal repayment of \$25,000 was made to reduce the principal balance. The loan continues with Thrivent Financial with a monthly payment of \$7,283 due.



CHRISTIAN EDUCATION 2022

CHRISTIAN EDUCATION at Lutheran Church of the Holy Spirit is an important way to cultivate and strengthen the faith of both children and adults. Our talented staff and the volunteers who lead these programs are also integral to their success.

Sunday School

We were happy to hold in-person Sunday School all year. It has been a combined class each Sunday during the 9:30 service, with the children departing following the children's sermon and returning for communion. Attendees were required to wear masks at the beginning of the year, but masking is now optional for students and teachers. Teams of 2 teachers rotate teaching the combined class. Lessons continue to be Bible-based, with older kids reading aloud to the group, videos, activities, and everyone participating in discussions about our faith and relationship with God. Curriculum and planning are spearheaded by Children's Ministry Director, Jennifer Williams.

A number of enjoyable events were held throughout the year, including a Mardi Gras celebration, Backpack Blessing, and more. Nine students took their First Communion on March 13, 2022.

Cherub choir has not yet resumed since we only have one service, though Nancy Fencl plans to restart a children's choir on Sundays in January 2023.

Confirmation

Seventh and eighth grade youth participate in Confirmation class on Tuesday evenings. Confirmation is a program designed to foster growth of the confirmand's knowledge of the Bible and Christian faith, with a specific focus on Lutheran traditions and identity. The program also provides an opportunity for service and getting involved with other ministries in the church. The individualized learning format allows for flexible class schedules with clearly defined expectations and goals for the young people in their growth toward becoming confirmed members of LCHS. Confirmation classes have been back in person throughout 2022. Eight confirmands completed their Affirmation of Faith and became full members of our congregation on May 22, 2022.

Tuesday LYFE

Lutheran Youth Fellowship Experience (LYFE) is a unique youth program offered to 2nd-6th graders. It brings faith and friendship into the lives of these students on Tuesday evenings. Throughout 2022, LYFE has been back in person, indoors, with a faith and fellowship activity led by Jennifer Williams, followed by Music with Bill Vaananen. LYFE attendance has been strong and the LYFE choir has sung during the church service a number of times throughout the year. The annual LYFE Christmas program, Light Up Bethlehem, really "rocked" on December 10, when an "old school" shepherd brought the Dead Sea Songs to teach a bunch of pop stars the great traditional carols of Jesus' birth.

Vacation Bible School

Traditional VBS was not held in the summer of 2022. Significant volunteer support is needed to make VBS successful and attendance at summer activities was sparse. Family activities included three small "s'mores and more" evening fellowship sessions. Additionally, we hosted once again the "Itty Bitty Bible Camp" August 2-4 was hosted for 4-6 year olds for 3 days at the beginning of August, studying Moses' trip down the Nile.

Adult Forum

Historically, LCHS has offered an adult education forum on Sunday morning during the Christian Education hour between services (9:45-10:30 a.m.). Attendees participated in faith-based educational discussions with a small group and Pastor Tim. Adult forum has historically been open to all adults, but has not resumed since we have been holding only one service.

Thursday Bible Study

The Thursday Bible Study group has continued to meet throughout 2022, primarily in person, with Zoom meetings as needed. Topics in 2022 included: John Goldingay's book on *Daniel and the 12 Minor Prophets*, Richard Rohr's *The Universal Christ: How a Forgotten Reality can Change Everything we See, Hope For, and Believe;* the third book in the *Forgotten Luther* series. Bible Study meets weekly from 10:15-11:30 and all are welcome.

Library

The LCHS Library services as a small group meeting place while offering reference materials such as Bible maps and atlases and introductory materials to other religions. Children's books are also available as resources for home-based religious education. Adult religious material (fiction and non-fiction) is available as well. Check out something new—keep it or pass it on. No due dates!

CHURCH GROWTH 2022

Our Holy Spirit family continued to show its resilience and love for one another as we navigated the progressive return to 'normalcy' following the pandemic, and yet still found safe and healthy ways to share the good news of Christ in 2022.

Our membership at the end of this year stood at 519 baptized members and 452 confirmed members. Inperson worship service remains at 9:30 am - keeping with LCHS' 'mask optional' policy. Holy Spirit continues to offer Facebook Live and a YouTube channel to virtually minister to those who prefer viewing services from the safety of their own homes.

GROWTH

Our banner of support to our neighbors came in many versions including increased signage in the Lincolnshire kiosk. More specifically, advertising of this year's Blood Drive, Trunk or Treat, Thanksgiving Service, Christmas Eve Services, and Outdoor Movie Night hung for one week at a time. Increased Facebook and Instagram presence has seen improved community members' participation at aforementioned events. Community events such as Truck or Treat, and Movie Night were also shared in the d103 Schools' Weekly Newsletters.

LCHS participated in the Buffalo Grove area's Pride Parade in June, handing out hand sanitizer bottles with our information and festive stickers.

Individual yard signs, and LCHS face masks remain available for interested parties to purchase.

On-going support of our members and visitors included personal hand-written Cards of Care (in Feb. 2022), and Cards of Welcome (once visitors' information was shared). With that, a QR code (linked to a 'Welcome' Google Information Form) is now on display in the Narthex as well as in the church bulletin - to create a dig tally-pleasing option for visitors to complete.

HOSPITALITY

Beginning in March, Meet and Greet Sundays returned to Holy Spirit. Gathering after service on the last Sunday of every month proved be a refreshing reminder of Fellowship. Thanks to the assistance of Katie Bally and Tom and Eileen Weglarz for their willingness and help.

In October of 2022, Holy Spirit offered congregants name tags to wear in combination with the Meet and Greet Sundays. The overall response was a very positive one. Our sense of Fellowship and belonging continued to grow.

Holy Spirit's outreach in 2022 also included the continued support we gave to each other and to our neighbors. Successful food drives for PADS and COOL let our neighbors know they were not forgotten. The Vernon Township food pantry received Thanksgiving baskets, and responses to our Angel Tree needs were, again, overwhelming. Those activities are noted in other sections of this Annual Report. However, it is important to remember that our continued church growth is thanks to a large degree to the caring people of Holy Spirit who share God's blessings with others.

The reduction in income which Holy Spirit has suffered the last few years, which we believe has been mostly caused by the covid pandemic, seems to be ending. The number of pledges we have received for 2023 has increased from the amount pledged in 2022, and has almost reached the amount pledged in 2021. FINANCE REPORT 2022

The Operating Fund ended the year in a negative position with expenses exceeding income by \$32,489. Benevolence of \$13,855 was paid to the ELCA Metro Chicago Synod. The Building a Foundation Building Fund appeal received pledges of \$312,000 in May, 2020. As of the end of 2022, total building fund receipts are \$286,180, which is 92% of the pledged amount. The balance of the Building Fund at the end of 2022 is \$100,926. No mortgage principal prepayment was made in 2022. The current mortgage balance as of the end of 2022 is \$595,981. The mortgage maturity date is May 15, 2031, and the interest rate was reduced in January 2020 to 4.0%. This rate will adjust again in January of 2027. Currently the required monthly mortgage payment of principal and interest is \$7,237. In 2022 we renewed a \$50,000 line of Credit with Bank Financial in case of emergencies. There are no current plans to use this credit, it has a cost of \$250/yr.

Thank you to the members of the Financial Review Committee: Arnie Bilstad, Allison Wyrwicz, and Julie Utterback. This committee reviews the church's financial records and provides valued insight over the church's financial state. A big thank you to Daaron Dohler who as Church Treasurer has contributed many hours and much attention to detail this year. Counters Jeanne Nelson, Eileen Hoffman, Jackie Murphy, Al Edwards, and Tom and Eileen Weglarz take turns counting the monies received the preceding week and preparing the deposit. The information is entered by the Office Manager, Ciara Cruz, into the church's financial record-keeping software.

The Financial Review Committee met with the Church Treasurer (Daaron Dohler) and Council Vice President (Larry Brady) to review the procedures of the Church regarding financial matters and the financial records of the Church and to review the procedures regarding the Building Fund, Endowment Fund and Columbarium accounts. The Financial Review Committee has concluded that appropriate controls are in place regarding the collection and deposit of funds received by the Church into the appropriate accounts. The Committee is also of the opinion that the Church follows reasonable procedures to track and approve the expenditure of funds and sees to it that all expenditures are charged to the appropriate budget accounts. The Committee reviewed the financial records and funds expended and concluded that the officers of the Church are following proper procedures in reconciling the income and expenditure of funds with the statement of accounts received from the Church's bank. The Committee further finds that the Treasurer maintains the proper records in the proper format. A review of actual checks written during the year indicates the income and expenditures of the Church are properly and appropriately posted to the financial records maintained by the Treasurer, which records accurately reflect the financial condition of the Lutheran Church of the Holy Spirit.
